RULES AND REGULATIONS
(Articles of Association / Bye - Laws)

1. Name of the Society :: **ADIL EDUCATIONAL SOCIETY, ADILABAD**
2. Location of the Office :: H.No. 4-3-60/7, Opp: Bus Stand,
ADILABAD.
3. i) Membership :: Any Major Indian Citizen
ii) Category of Member :: General only
iii) Admission fee and annual subscription/monthly subscription:: Rs. 1,000 - 00
Nil
4. General Body
i) Annual General Body will meet once in a year i.e. in the month of March or as required.
ii) FUNCTIONS
a. To pass the budget for the ensuing year and approve the expenditure statement of previous year.
b. To approve the report of the activities of the Society.
c. To elect the Executive Committee etc.,
d. To appoint Auditor.
e. To take loans from Financial Institutions as per requirements of the Society.
5. (i) **Executive Committee:** Shall consist of seven (7) Members and out of them the following office bearers shall be elected by the E.C. viz., President, Vice President, General Secretary, Joint Secretary and Treasurers and two (2) E.C. Members.
5. (ii) General Body consists of all the members including Executive Committee. The members of the Executive Committee (Governing Body) shall be duly bound to attest the Signatures of all the members of newly elected Executive Committee and see that the said Signatures of the out going Governing Body tally with the annual list as filed with the Registrar of Societies before 15 days the succeeding month in which elections were held and changes thereon if any.

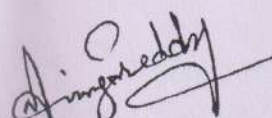
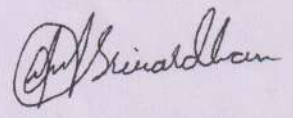

iii) **FUNCTIONS OF THE EXECUTIVE COMMITTEE AND OFFICE BEARERS:**


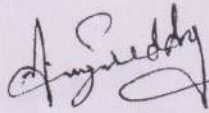

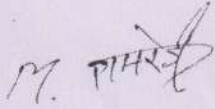

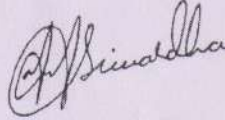
1. **PRESIDENT:** He presides over all the meetings of the Executive Committee. He can cast his vote in the case of a tie in decision making. He can supervise all branches of the society.
2. **VICE PRESIDENT:** He shall assist the President in discharging his functions. In the absence of the President he will perform the duties of the President or other duties as entrusted by the President.
3. **SECRETARY:** He is Chief Executive Officer of the Society and Custodian of all records relating to the Society and Correspondent on behalf of the Society. He has to take on Record all minutes of the Society. He would convene both the Executive Committee and General Body of the Society with the permission of the President. He guides the Treasurer in preparing the budget and expenditure statement to place before the General Body for its approval.
4. **JOINT SECRETARY:** He has to do the work entrusted by the Executive Committee. He has to assist the Secretary in discharging his duties. In the absence of the Secretary, he can perform the duties of the Secretary.
5. **TREASURER:** He is responsible for all financial transactions and Funds of the Society. He has to maintain and operate the accounts of the Society jointly with the Secretary or President.
6. **OFFICE BEARERS:** Are the responsible persons to attend to such activities of the Society which the Executive Committee entrusts to them.
7. **QUORUM:** Half of the total members for General Body Meeting and $\frac{1}{4}$ for Executive Committee Meeting.
8. **FUNDS:** The funds shall be spent only for the attainment of the objects of the Society and no portion there of shall be paid / transferred directly or indirectly to any of the member through any means. All financial amendments and alterations in any of the clauses of Articles of Association shall be sent to the Commissioner of Income Tax, Andhra Pradesh for his prior approval and thereafter only the amendmets and alterations shall be deemed to be incorporated in the Articles of Association.
9. **AMENDMENTS:** No amendment or alteration shall be made in the Bye-Laws of the Association unless it is voted by $\frac{2}{3}$ rd of its members present at a special meeting convened for the purpose and confirmed by $\frac{2}{3}$ rd of the members present at a second special meeting.
10. **WINDING UP:** In case the Society has to be wound up the property and funds of the Society that remain after discharging the liabilities, if any, shall be transferred or paid to some other institutions having similar aims and objects.

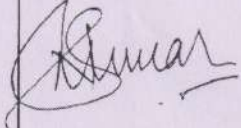
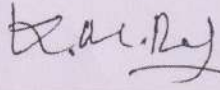

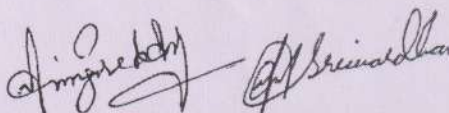
